Use of Transport	Staff Pupils Others	Infection Control	<ul> <li>It is recommended that facemasks are worn in enclosed and crowded spaces where you may come into contact with people you don't normally meet. This includes public transport and dedicated transport to school.</li> <li>It is important to ensure vehicles are well ventilated when occupied, by opening windows and ceiling vents. <ul> <li>It is recommended that children and young people aged 11 and over continue to wear a face covering when travelling to secondary school or college.</li> </ul>	
It is no longer recommended maximising distance and minimising mixing, but unnecessary risks such overcrowding should be minimised.	
Children, young people and adults should follow public health advice on when to self-isolate and what to do.	
<ul> <li>They should not board dedicated transport or public transport if they have symptoms or other reasons requiring them to stay at home due to the risk of them passing on COVID-19.</li> </ul>	
<ul> <li>If a child or young person develops COVID-19 symptoms, however mild, while at school, they will be sent home.</li> </ul>	
<ul> <li>They should avoid using public transport and, wherever possible, be collected by a member of their family or household.</li> </ul>	
In exceptional circumstances, if parents or carers cannot arrange to have their child collected, and it is age-appropriate and safe to do so, the child should walk, cycle or scoot home. If this is not possible, alternative arrangements may need to be

If disposable cloths are not available use once and then put in wash.</li> <li>Regular cleaning of surfaces will reduce the risk of spreading the virus.</li> <li>All used cloths thrown away to be double bagged and then placed in a secure area i.e. lockable bin.</li> <li>On site cleaning to be provided by ATT's Cleaning services provider to complete dedicated cleans tice daily.</li> </ul>	MED	<b>√</b>
Ventilation class/office	Pupils Staff	Infection control	<ul> <li>Identify any poorly ventilated spaces and take steps to improve fresh air flow</li> <li>If mechanical ventilation systems are used to draw fresh air or extract air from a room these should be adjusted to increase the ventilation rate wherever possible</li> <li>Ensure that mechanical ventilation systems only circulate fresh outside air and where this is not possible, in a single room supplement with an outdoor air supply</li> </ul>	MED	<b>√</b>

Spread of infection	Staff Pupils Others	Lack of infection control	<ul> <li>Spillages of bodily fluids, e.g. respiratory and nasal discharges, are cleaned up immediately in line with guidance, using PPE at all times.</li> <li>Parents are informed not to bring their children to the academy or on the premises if they show signs of being unwell and believe they have been exposed to coronavirus.</li> <li>Staff and pupils do not return to the academy before the minimum recommended exclusion period (or the 'self-isolation' period) has passed, in line with national guidance.</li> <li>Pupils who are unwell are not taken on Educational Visits or permitted to enter public areas used for teaching, e.g. swimming pools.</li> <li>Parents notify the Academy if their child has an impaired immune system or a medical condition that means they are vulnerable to infections.</li> <li>The Academy in liaison with individuals' medical professionals where necessary, reviews the needs of pupils who are vulnerable to infections.</li> <li>Any additional provisions for pupils who are vulnerable to infections are put in place by the Principal, in liaison with the pupil's parents where necessary.</li> </ul>	MED	*

<ul> <li>kept up-to-date with national guidance about the signs, symptoms and transmission of coronavirus.</li> <li>Any pupil or member of staff who displays signs of being unwell, such as having a cough, fever or a loss or change to their sense of smell or taste, and believes they have been exposed to coronavirus, is immediately taken out of the class and placed in an area where they will not come into contact with others and are supervised at all times.</li> <li>For pupils, the relevant member of staff calls for emergency assistance immediately if pupils' symptoms worsen.</li> <li>The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff.</li> <li>Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in governmental guidance.</li> <li>Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others.</li> <li>Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all</li> </ul>	
<ul> <li>If unwell pupils and staff are waiting to go home, they are instructed to use different toilets to the rest of the Academy to minimise the spread of infection.</li> </ul>	
<ul> <li>Any pupils who display signs of infection are taken home immediately, or as soon as practicable, by their parents – the parents are advised to contact NHS</li> </ul>	



			<ul> <li>111 immediately or call 999 if the pupil becomes seriously ill or their life is at risk.</li> <li>Any members of staff who display signs of infection are sent home immediately and are advised to contact NHS 111 immediately or call 999 if they become seriously ill or their life is at risk.</li> <li>Any medication given to ease the unwell individual's symptoms, e.g. Paracetamol, is administered in accordance with the Administering Medications Policy.</li> </ul>

			<ul> <li>they are contacted by NHS Test and Trace as a close contact of a positive COVID-19 case.</li> <li>Instead, children will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a PCR test.</li> <li>We would encourage all individuals to take a PCR test if advised to do so.</li> <li>Staff / Pupils</li> <li>with a positive lateral flow test result should self-isolate in line with the stay at home guidance and get a PCR test to check if they have COVID-19 and continue to self-isolate</li> <li>If the PCR test is taken within 2 days of the positive lateral flow test, and is negative, it overrides the self test and the pupils/staff can return to the Academy as long as the individual doesn't have COVID-19 symptoms</li> </ul>

<u>Contingency framework: education and childcare settings</u> (publishing.service.gov.uk)

The thresholds, detailed below, can be used by settings as an indication for when to seek public health advice if they are concerned.

For most education and childcare settings, whichever of these thresholds is reached first:

- 5 children, pupils, students or staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period: or
- 10% of children, pupils, students or staff who are likely to have mixed closely test positive for COVID-19 within a 10-day period
- For special schools, residential settings, and settings that operate with 20 or fewer children, pupils, students and staff at any one time:
- All settings should seek public health advice if a pupil, student, child or staff member is admitted to hospital with COVID-19 by phoning the DfE helpline (0800 046 8687, option 1), or in line with other local arrangements. Hospitalisation could indicate increased severity of illness or a new variant of concern. Settings may be offered public health

If a parent or carer insists on a pupil attending your Academy, you can take the decision to refuse the pupil if, in your reasonable judgement, it is necessary to protect other pupils and staff from possible infection with COVID-19.</li> <li>Your decision would need to be carefully considered in light of all the circumstances and current public health advice.</li> </ul>	MED	<b>✓</b>

Admitting people into the Academy	Pupils Staff	Infection control	<ul> <li>Pupils, staff and other adults should not come into the Academy if they have symptoms, have had a positive test result or have been instructed to quarantine</li> <li>Anyone staff or pupils within the Academy who appear to have COVID-19 symptoms are sent home, advised to avoid using public transport and, wherever possible, be collected by a member of their family or household and to follow public health advice</li> <li>In the case of a pupil awaiting collection, they should be taken to a room away from other pupils and supervised</li> <li>If the member of staff is in close contact with the child then they should wear appropriate PPE</li> <li>A window should be opened for fresh air ventilation if possible</li> <li>Any rooms that have been used for this purpose should be cleaned after they have left</li> <li>As anyone within the household should follow the PHE guidance for households with possible or confirmed COVID-19 infection, then any siblings within the Academy will be identified and also sent home.</li> </ul>	MED	✓

Out of school settings will not be expected to undertake contact tracing.</li> <li>Individuals are not required to self-isolate if they are a close contact of someone with COVID-19 if they are fully vaccinated, below the age of 18 years and 6 months, taking part in an approved COVID-19 vaccine trial or are unable to get vaccinated for medical reasons. Instead they will be advised to take a PCR test.
